RE: Texas LNG LLC (Docket No. 13-160-LNG)

Dear Ms. Moore:

On December 31, 2013, Texas LNG LLC (“Texas LNG”) filed in FE Docket No. 13-160-LNG for FTA and non-FTA export authorizations. This filing was supplemented by a subsequent filing dated April 27, 2014. DOE/FE issued the requested FTA authorization in DOE/FE Order No. 3443 (June 22, 2014). The non-FTA export authorization Application in the Docket remains pending.

Subsequently, Texas LNG Brownsville LLC (“Texas LNG Brownsville”) filed in FE Docket No. 15-62-LNG for FTA and non-FTA export authorization. This filing was supplemented and amended by filing a First Amendment on May 22, 2015. In Docket No. 15-62-LNG, Texas LNG Brownsville respectfully requested that the FTA application in Docket No. 13-160-LNG remain in effect until DOE/FE acts on the authorization requested in the Docket No. 15-62-LNG, at which time Docket No. 13-160-LNG would be novated.

In order to clarify the intent of the aforementioned filings, Texas LNG hereby requests DOE to vacate the FTA authorization in Order No. 3443 upon the same date that DOE issues an order in Docket No. 15-62-LNG authorizing Texas LNG Brownsville to export LNG to FTA countries. Texas LNG further requests that DOE permit it to withdraw the application for non-FTA export authorization pending in Docket No. 13-160-LNG upon the same date that DOE issues an FTA export authorization to Texas LNG in Docket No. 15-62-LNG. The non-FTA portion of Docket No. 15-62-LNG will remain pending before the DOE.
