I am writing on behalf of McAllen Economic Development Corporation in support of Gulf Coast LNG Export, LLC's application for long-term authorization to export domestically produced liquefied natural gas (LNG). MEDC is a not-for-profit under contract by the City of McAllen to create jobs by attracting new industry and helping existing companies expand within the City of McAllen and Reynosa. While our primary focus is creating jobs for McAllen and Reynosa, we also work hard to improve the South Texas Region. The exportation of liquefied natural gas by Gulf Coast LNG Export, LLC, will create hundreds of jobs in the first phase and thousands to be projected by 2018, which will benefit the overall economy in the South Texas Region.

As you are aware, Gulf Coast LNG is proposing a significant new investment to construct facilities in Brownsville, Texas that would allow for the receipt and liquefaction of natural gas and the export of LNG. We support the Gulf Coast LNG project because of the significant job creation and positive economic impact it will have to our community. Brownsville, Texas has a large population looking for good paying permanent jobs. The Gulf Coast LNG project will help the Brownsville community by supplying thousands of jobs, increasing the local tax base and improving the standard of living.
