Dear Secretary Chu:

At NiSource Gas Transmission & Storage (NGT&S), we are investing in a broad array of value-adding pipeline infrastructure projects to enhance our existing 15,000-mile natural gas transmission pipeline network. Serving Mid-Atlantic, East Coast and Gulf Coast markets, we have witnessed the natural gas revolution that is transforming our country, stimulating local economies and creating millions of jobs. The recent innovations in shale gas technology and surge in natural gas production provide our nation with an attractive new opportunity – exports of liquefied natural gas (LNG). NGT&S strongly supports this opportunity.

The report conducted for the Department of Energy (DOE) entitled "Macroeconomic Impacts of LNG Exports from the United States" examines a range of scenarios, with varying assumptions about supply and demand.
